#### REPORT OF THE COUNCIL

At the Annual General Meeting on 7th December 2000 Miss Helen McDonald gave a lecture entitled "Recent excavations at Tell Brak". On March 15<sup>th</sup> Dr Stuart Campell lectured on "Umm Dabaghiyah in a contemporary context". Our invited speakers for the nineteenth Bonham Carter Lecture on June 21<sup>st</sup> were Dr Alastair Northedge on 'The Abbasid palaces of Samarra' & Professor Robert Hillenbrand on 'The medieval Islamic architecture of Mosul'.

At the Council Meeting on March 15th Professor Postgate announced his resignation from the post of Chairman. Professor Postgate has made an enormous contribution to the work of the School, which owes him warmest thanks for all he has done. It is a pleasure to announce that he will continue to serve the School, as a member of Council and of the Fellowship and Research Committee. At the Council meeting in March, Dr Crawford was elected as Chairman and Professor Millard succeeds Dr Crawford as Vice-Chairman. Dr Crawford is a Reader at the Institute of Archaeology, University College London, who currently co-directs the British Archaeological Expedition to Kuwait, one of the School's major field projects. Professor Millard is Rankin Professor of Hebrew and Ancient Semitic languages at the University of Liverpool and the co-editor of the recently published Dictionary of the Ancient Near East.

In December, Mr Christopher Walker resigned after twenty years as a Council member. He also served as Hon. Secretary and his experience and his incisive and practical approach to problems will be greatly missed. Professor D.J. Wiseman stepped down from his role as President of the School and he too will be greatly missed. He has served in many capacities, including Chairman of the School for many years. We welcomed Professor David Oates as the School's new President and Mrs Rachel Maxwell-Hyslop as a new Vice President. Anna Lethbridge resigned as Publications Officer of the School last November to pursue her own publishing interests. We thank her for her dedication in this important role and for being our first Newsletter Editor. We were saddened to hear of the death of one of our Vice Presidents, Professor O.R. Gurney, on January 11<sup>th</sup> 2001 and an appreciation of his life written by James Kinnier Wilson appears in our May 2001 Newsletter (No. 7).

The School continues to try to assist its academic colleagues in Iraq by sending them books and periodicals whenever the opportunity arises. It is impossible to buy these in Baghdad because of the international sanctions. In addition, the School has made a financial contribution to a programme being run by UNESCO to assist the Iraq Museum with the conservation of a number of important artefacts, whose state of preservation has suffered as a result of the Gulf War and its aftermath.

Fieldwork continued in Syria and Kuwait. The third season of excavations at Chagar Bazar took place in March-May 2001. Dr Augusta McMahon reports work at Chagar Bazar concentrated on levels of the early 2nd millennium BC in two areas. In Area A they have exposed a set of substantial buildings, at least some of which had a public function. In Area G they have the contrast of a contemporary neighborhood of private houses. A report on these excavations will appear in *IRAQ* LXIII.

In March 2001 excavations resumed at Tell Brak under the overall direction of Professor David Oates, with Dr Geoff Emberling and Miss Helen McDonald acting as joint field directors. Miss Helen McDonald became the School's Senior Research Fellow in 2000. Excavation was undertaken in three areas: Area TC, in which they continued investigation of a burned late Early Dynastic building (the so-called Brak Oval) as well as overlying levels of Akkadian date; Area TW, in which they continued work on the sequence of occupation during the 4<sup>th</sup> millennium BC; and a new trench near TW called TX. This latter trench was the beginning of a programme to investigate the Late Uruk period settlement in areas of the site other than TW. Excavations at Tell Brak Vol. 2: Nagar in the third millennium BC by David Oates, Joan Oates & Helen McDonald will be printed in late 2001 (published jointly with the McDonald Institute of Archaeological Research in Cambridge).

Dr Harriet Crawford and Dr Rob Carter had a further successful season at H3 at Es-Sabiyah in Kuwait in the Spring 2000. The two month season, carried out jointly with a team from the National Museum of Kuwait and Institute of Archaeology, University College London, made a number of important finds which enlarge and refine our picture of the cultures of the Arabian Neolithic in the sixth millennium BC and throw light on their relations with their neighbours. The unique cellular building, which was first identified in the second season, was explored further and it is clear that it was modified a number of times during its lifetime. The remains of two other stone structures were also uncovered. Although a few fragments of bitumen were found in the first two seasons, this year's work produced bitumen of a different order, some of it apparently stored in the buildings as slabs waiting to be recycled. A few of these slabs appear to have come from ancient boats as they have barnacles on one face and impressions of what seem to be reeds and rope on the other. If further study confirms this interpretation, they may well be some of the earliest fragments of boats in the world. The importance of boats to the people of H3 was further underlined by the discovery of a charming model boat about c.13 cms long, made of the local reddish clay, which was found tucked under the wall in the southern courtyard.

Grants for the 2000/01 session reflected in these accounts were awarded to the following: Dr Heather D. Baker for work at the British Museum copying and collating Neo-Babylonian tablets from the archive of the 6th-5th century Nappahu family of Babylon; Dr Georgina Herrmann, for a visit to Baghdad in 2001 to study ivories from Nimrud: Dr Erica Hunter, for the translation of Arabic entries in the Iraq Museum catalogue on Aramaic and Mandaic incantation bowls from the Sassanian site of Tell Dhuihi near Kish: Dr John MacGinnis, for his participation in excavations in the Neo-Assyrian levels of the site of Ziyaret in south-eastern Turkey; Mr Jonathan Taylor, for a visit to the University Museum, Pennsylvania, to work on Sumerian lexical tablets belonging to the series "Proto-Lu": Professor Andrew George for work on the Gilgamesh Tablets in the Baghdad Museum and to present a paper to the Baghdad writing conference; Professor Shereen Ratnagar to support research work on a radical revision of her book *Encounter*, the Westerly Trade of the Harappan Civilization (1981); Dr Peter Magee to support the Geophysical Survey of the entire area of Muweilah, UAE; Dr Rafal Kolinski was awarded a special grant to work on the finds in the British Museum from Sir Max Mallowan's excavations at Tell Arbid in Syria in 1936. Dr Robert Carter was awarded a grant to study the pottery and small finds from the Central Gulf sites at the Dhahran Museum for comparative purposes with the BAEK finds at H3 but was unable to utilise this grant.

Initial grants for the 2001/2002 session have been awarded to the following: Dr John MacGinnis to cover travel costs to the Assyrian site of Ziyaret Tepe in south-eastern Turkey and to contribute towards the costs of two weeks' maintenance to write up the results of the excavation; Dr Derek Kennet to cover travel costs to Dubai and to assist in the completion of the catalogue and study of the glass assemblage from the Kush excavations in Ras al-Khaimah (UAE); Dr Michael Charles & Dr Keith Dobney for the initial phase of an updateable electronic database for Mesopotamia of environmental evidence from sites in Iraq, which will be available via the Web; Dr Georgina Herrmann to assist with travel costs of a visit to Baghdad with a photographer to work on the ivories from SW11/12, Fort Shalmaneser and for drawing and photography costs related to the ivories from the North West Palace; David Thomas for work on developing the Nimrud Database Project to computerise and rationalise records from the School's activities at Nimrud (1948-1963).

The Nimrud Conference, sponsored jointly by the British Museum and the School, scheduled to take place November  $21^{st}-23^{rd}$ , 2001 at the British Museum to coincide with the Museum's exhibition "Agatha Christie and the Orient" (November 2001 – March 2002) has been postponed. The Fifth Millennium BC in the Near East Conference, jointly arranged by Manchester and Liverpool Universities with the sponsorship from Schools and Institutes including the BSAI, will be taking place on November  $16^{th}$ -  $18^{th}$  at the Merseyside Maritime Museum, Liverpool. The conference has a full programme of c. forty contributions (from UK, Europe, USA, Middle East, Japan and Canada) that offer a very full set of sessions.

The School's Publication programme continues with the recent publication of *The Nimrud Letters*, 1952, (Cuneiform Texts from Nimrud Vol. V) edited by H W Saggs (2001). In addition to *Excavations at Tell Brak Vol. 2*, the following publications will be forthcoming in 2001: *Nimrud - An Assyrian Imperial City Revealed* by Joan and David Oates; *Artefacts of Complexity: Tracking the Uruk in the Near East* (Iraq Archaeological Reports Volume 5).

As the 2000/2001 accounts show, our income rose slightly last year. The School's regular grant from the Academy increased but was offset by the significantly increased expenditure on fieldwork and research and an unrealised loss on our COIF endowment fund. Thus, the financial year ended with a decrease in our reserves, which we believe continue to be maintained at a satisfactory level for the operation of the School. The School has had premises in the British Academy for the past year, which have proved highly beneficial to the running of the School and provide contacts with other Schools and Institutes. We remain grateful for the continuing support, which the Academy gives the School.

## REPORT OF THE AUDITORS TO THE TRUSTEES OF THE BRITISH SCHOOL OF ARCHAEOLOGY IN IRAQ

We have audited the financial statements on pages 2 to 10 which have been prepared under the historical cost convention, as modified by the revaluation of investments and the accounting policies set out on page 5.

## RESPECTIVE RESPONSIBILITIES OF THE TRUSTEES AND AUDITORS

As described on page 5, the Charity's Trustees are responsible for the preparation of financial statements. It is our responsibility to form an independent opinion, based on our audit, on those statements and to report our opinion to you.

#### BASIS OF OPINION

We conducted our audit under s43 of the Charities Act 1993 and in accordance with regulations made under s44 of that Act, and in accordance with auditing standards issued by the Auditing Practices Board. An audit includes an examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements. It also includes an assessment of the significant estimates and judgements made in the preparation of the financial statements, and an assessment of whether the accounting policies are appropriate to the Charity's circumstances, consistently applied and adequately disclosed.

We planned and performed our audit so as to obtain all the information and explanations which we considered necessary in order to provide us with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or other irregularity or error. In forming our opinion we also evaluated the overall adequacy of the presentation of information in the financial statements.

Where we have been unable to obtain independent confirmation of the completeness of the transactions in Iraq, and of subscriptions and publication sales, we have accepted assurances from the Chairman and Treasurer that all transactions have been reflected in the Accounts.

#### **OUALIFIED OPINION ARISING FROM LIMITATION IN AUDIT SCOPE**

Except for any adjustments that might have been found to be necessary had we obtained independent confirmation of the above items, in our opinion the Financial Statements give a true and fair view of the state of the Charity's affairs at 31st March 2001 and of its incoming resources and application of resources for the year then ended, and have been properly prepared in accordance with the Charities Act 1993.

### NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31ST MARCH 2001

#### 1. ACCOUNTING POLICIES

- The accounts have been prepared in accordance with applicable accounting principles under the historical cost convention, modified by the revaluation of investments.
- b) Direct currency conversions are translated at the exchange rate at the time of transaction, other balances are converted at year end rates, any difference arising on exchange is written off in the year concerned.
- c) The School's financial statements have been prepared to comply with the 'Statement of Recommended Practice' (SORP) for charities, produced by the Charity Commission and thus with the accounting requirements of the Charities Act 1993.
- d) Investments are included at market value. All other assets are included at cost or net realisable value, if lower.
- e) Grants are included in the Accounts in the period to which they relate.
- f) The School owns a collection of tablets and ivories from its excavations. These are on deposit with the British Museum at present and a valuation is currently being sought. These items are not included in the Accounts.

#### g) STATEMENT OF TRUSTEES' RESPONSIBILITIES

Charity law requires the Trustees to prepare financial statements for each financial year, which give a true and fair view of the state of affairs of the Charity and of its financial activities for that period. In preparing those financial statements the Trustees are required to:

- (i) select suitable accounting policies and then apply them consistently;
- (ii) make judgements and estimates that are reasonable and prudent;
- (iii) state whether the policies adopted are in accordance with the appropriate SORP on Accounting by Charities and the Accounting Regulations and with applicable accounting standards, subject to any material departures disclosed and explained in the financial statements; and
- (iv) prepare the financial statements on the going concern basis unless it is inappropriate to assume that the Charity will continue in business.

The Trustees are responsible for keeping proper accounting records which disclose, with reasonable accuracy at any time the financial position of the Charity, and to enable them to ensure that the financial statements comply with applicable Accounting Standards and Statements of Recommended Practice and the regulations made under s44 of the Charities Act 1993. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud or other irregularities.
